

#### **CALL FOR APPLICATIONS - SUPPORT FOR CREATION 2026**

## Residency and pre-purchase

**Duration**: 1 to 2 weeks + 2 public performances between the end of the residency and the

rendez-vous "Bien Tenté" in French-speaking Switzerland.

Period: January - November 2026

Deadline for receipt of applications: 12 April 2025

Every season, the CCHAR hosts Swiss companies and artists in residence who are creating for the street and public space and accompanies them on the RDV "Bien Tenté" in Switzerland.

These residencies give artists the opportunity to develop their research, work on stage or in the streets of La Chaux-de-Fonds and give their first public performances. Then they can test their shows as part of a "Bien Tenté" Suisse season.

## **TERMS AND CONDITIONS**

## Who is this appeal aimed at?

- Professional creators who work on the street, in public spaces, outside the walls, specific sites, non-dedicated places, contextual theatre, etc.
- Swiss artists or artists domiciled in Switzerland at the time of submission of the application. If the project is a collaboration, at least half of the creators must be Swiss, or resident in Switzerland.
- In all disciplines: dance, theatre, circus, puppetry, clowning, object theatre, performance...
- · In all langages

## Selection:

The selection committee is made up of performing arts professionals and the CCHAR team. It is attentive to various criteria, including :

- the aesthetics and content
- technical and financial feasibility
- the variety of disciplines and formats
- the target groups
- gender parity
- emerging companies / established companies

The CCHAR is recognised by the SSA as a place of creative residence.



## **CCHAR's contributions:**

The company is **hosted for one or two weeks**, **depending on requirements**. The residencies end with public performances. The CCHAR's contributions take the form of:

- Provision of a rehearsal room
- The provision of a residence flat
- Communications support (newsletter, announcements, programmes)
- Sending out business invitations
- · Negotiating the conditions of use of public space and payment of fees
- Pre-purchase of 2 performances; the amount depends on the number of people involved in the residency.
- Payments of royalties
- Facilitating discussions with the public using the Feed Back method\*.
- A day of work and discussion with an experienced director or playwright, depending on the project, with or without the audience present
- A session with a professional photographer and provision of photos for use on the networks
- Depending on the project, upstream mediation activities and/or meetings with the public can be supported by our teams
- Representation and promotion of selected projects at Swiss and foreign festivals, professional meetings, juries, trade fairs and cooperation programs.

## The 2026 residence periods are as follows:

I - 12 to 23 January VI - 27 April to 9 May

II - 2 to 14 February VII - 18 to 30 May

III - 23 February to 7 March VIII – 14 to 26 September

IV - 16 to 28 March IX – 2 to 14 November

V - 6 to 18 April

#### Terms and conditions:

The CCHAR enters into an agreement that sets out in detail the nature and amount of its commitments. The company undertakes to mention the support of the CCHAR and its partners.
